

Winch, LED lights, and Snow Plow Mount shown in instructions are optional and are *not included* with FBG-P-RAN900











Remove stock Bumper from machine keep all components removed from machine







Do not tighten hardware completely unless noted.

- Use hardware shown and secure Mount (A) to Frame.





Winch installation:


SuperATV p/n 4500-W-N

- Install Winch to Mount (A) with hardware supplied with Winch.
- Tighten hardware completely.
- Wire Winch; see Winch Owners Manual.



- Use hardware shown and install Brush Guard (B) to Mount (A).
- Install Fairlead, supplied with Winch, to Brush Guard (B) with hardware supplied with Winch.
- Tighten hardware completely.







Align Brush Guard to machine and tighten hardware completely.

- Install Fairlead, supplied with Winch, to Fairlead Adapter (G) with hardware supplied with Winch.





- install D-Rings (F) to Mount (A).
